They didn't run a single test at Tulsi centre to do a thorough diagnosis of my mental condition, only a talk, dr. Ratnarakshit Ingole had with me at the center was their basis to declare that I have Schizophrenia and on that basis they forcefully gave me psychiatric medication in captivity for 1 month. They kept me at their center by force.

23/11/23, 4:34 pm - Rishi Mishra: After that my wife continued the psychiatric medication at home & I felt totally helpless against her. The doctors kept reducing the dose gradually and for the last 1 year I haven't taken any psychiatric medication.

23/11/23, 4:34 pm - Rishi Mishra: But, I think once again my family members may be plotting to get me admitted into psychiatric care center for reasons and motives totally unknown to me.
