INSTRUCTIONS FOR CANDIDATES WHO FILLED UNDERTAKING

Candidates who appeared for AIBE under an undertaking must complete their enrolment within six months of the AIBE result declaration or within 6 months of the declaration of LL.B final year results, in case they are awaiting results. Failure to do so will require them to reappear for AIBE to be eligible to practice law. The specific instructions for each category are as follows:

Category-wise Instructions:

1. Final Year Law Students (Not Yet Passed Out)

- If you have not yet received your final year results, your six-month enrolment period starts from the date of publication of your final year LL.B. result.
- You must enrol with the State Bar Council within six months of your final result declaration.
- If you fail to enrol within this time, you will have to reappear for AIBE to obtain a valid Certificate of Practice.

2. Law Graduates Awaiting Results

- If you have completed your final semester exams and are awaiting results, your six-month enrolment period starts from the date of declaration of your final LL.B. results.
- Enrolment with the State Bar Council is mandatory within this timeframe.
- Non-compliance will result in the requirement to reappear for AIBE.

3. Law Graduates (Not Yet Enrolled with State Bar Council)

- If you have completed your LL.B. but have not enrolled with the State Bar Council, you must do so within six months from the date of AIBE result declaration.
- If you fail to enrol within this period, your AIBE qualification will be deemed invalid, and you will need to reappear for AIBE.

4. Law Graduates Currently Employed (Who Have Not Enrolled or Have Surrendered Enrolment)

- If you have surrendered your enrolment certificate due to employment, you must re-enrol with the State Bar Council within six months of passing AIBE.
- If you fail to enrol within the stipulated time, you will need to reappear for AIBE before practicing law.

GENERAL INSTRUCTIONS:

1. Verification of Details:

2. Submission of Required Documents:

- Candidates may be required to submit attested copies of necessary documents as per the instructions provided in their result notification.

3. Enrolment Certificate Requirement:

- The Certificate of Practice will be issued by the Bar Council of India only after successful enrolment with a State Bar Council.
- Candidates must submit their enrolment certificate to the Bar Council of India to receive the Certificate of Practice.

4. Strict Compliance with Enrolment Requirement:

- State Bar Councils will strictly monitor the enrolment process.
- Candidates must furnish proof of enrolment within the prescribed period.

5. Due care has been taken while preparing the results, however, any inadvertent error cannot be ruled out. The Council reserves the right to rectify any such error at a later stage.
